

Minimum Wages Act, 1948 (Central Act XI of 1948) -Revision of minimum rates of wages for employment in Forestry - Preliminary Notification – Confirmed - orders - Issued.

In the Government Order first read above, the minimum rates of wages for the employment in Forestry were revised under the provisions of the Minimum Wages Act, 1948 (Central Act XI of 1948).

2) In the Government Order second read above, a Preliminary Notification was issued in order to revise further the minimum rates of wages for the employment in Forestry.

3) The Commissioner of Labour in his letter 3rd read above has stated that no objection and suggestion were received from the persons likely to be affected by such revision and requested the Government to confirm the above said Preliminary notification.

4) The Commissioner of Labour in his letter 4th read above has also suggested certain amendments to the Government Order and the Preliminary notification issued with the Government Order second read above and requested the Government to confirm the above said Preliminary Notification as per his letter dated 28.12.2012, after making necessary amendments to the said Government Order and the Preliminary Notification.

5) Accordingly in the Government Order 5th read above, necessary Amendments, have been issued to the Preliminary Notification in order to revise the minimum rates of wages for the employment in Forestry. Objections or suggestion has not been received from any person with respect of the said Preliminary

notification and the amendments issued there to subsequently. The Government have therefore decided to confirm the above said Preliminary Notification issued in the Government Order second read above, as subsequently amended.

6) The appended Notification will accordingly be published in the <u>Tamil</u> <u>Nadu Government Extraordinary Gazette</u> both in English and Tamil. The Secretary to Government, Tamil Development, and Information Department, Secretariat, Chennai-600 009 is requested to send the Tamil translation of the Notification to the Works Manager, Government Central Press, Chennai-600 079. The Works Manager, Government Central Press, Chennai-600 079 is requested to publish the Notification and send five copies of the Extraordinary Gazette to the Government for reference and record.

APPENDIX.

NOTIFICATION.

In exercise of the powers conferred by clause (b) of sub-section (1) of section 3 and sub-section (2) of section 5 of the Minimum Wages Act, 1948 (Central Act XI of 1948) and in supersession of the Labour and Employment Department Notification No.II(2)/LE/68/2003, published on page 40 of Part II - Section 2 of the <u>Tamil Nadu Government Gazette</u>, dated the 29th January 2003, the Governor of Tamil Nadu after consultation with the Advisory Board, hereby revises the minimum rates of wages payable to the classes of employees in the employment in Forestry in the State of Tamil Nadu, specified in column (1) of the Schedule below, as specified in the corresponding entries in column (2) thereof, the draft of the same having been previously published as required by clause (b) of sub-section (1) of section 5 of the said Act.

2) This Notification shall come into force with effect on and from the date of its publication in the <u>Tamil Nadu Government Gazette.</u>

Explanations.- (1)Dearness Allowance.- The employees shall be paid dearness allowance as indicated below:--

- (i) The wages notified above are linked to the Average Chennai City Consumer Price Index Number for the year 2000, (that is, 475 points with base 1982=100) and for every rise of one point over and above 475 points, an increase of 25 paise (twenty five paise only) per point per day shall be paid as dearness allowance.
- (ii) The dearness allowance shall be calculated on the first April of every year on the basis of the average indices for the earlier 12 months, that is, from January to December.
- (iii) The first calculation shall, thus, be made effective, from the date of publication of this Notification in the <u>Tamil Nadu Government</u> <u>Gazette</u>, based on the average of Consumer Price Index for the previous year.

(2) Where the nature of work is the same, no distinction in the payment of wages shall be made between men and women employees.

(3) The daily rate of wages and dearness allowance include the element of weekly holiday wages also.

(4) Wherever the existing wages are higher than the minimum rates of wages fixed herein, the same shall be continued to be paid.
