# APPENDIX NOTIFICATION

In exercise of the powers conferred by clause (a) of sub-section (1) of Section 3 and sub-section 5 of the Minimum wages Act, 1948 (Central Act XI of 1948) and in supersession of the Industries Labour and Co-operation Department Notification No. II-I No.300 of 1965 dated the 29<sup>th</sup> December1964, published at pages 106-107 of part II Section I of he Fort St. George Gazette, dated the 27<sup>th</sup> January 1965, the Governor of Tamil Nadu, having considered the advice of the committee appointed under clause (a) of sub-section (1) of section 5 of the said Ac tin regard to revising minimum rates of wages for employment under any local authority, hereby revises the minimum rates of wages specified in column(2) of the schedule below in respect of the said employment as payable to each class of the employees specified in the corresponding entries in column (1) thereof.

2. This Notification shall come into force with effect on and from the 1st July 1977.

## THE SCHEDULE

1. EMPLOYMENT UNDER ANY LOCAL AUTHORITY INCLUDING THE CORPORATIONS OF MADRAS AND MADURAI BUT OTHER THAN VILLAGE PANCHAYATS.

Classes of employees	Minimum rates of wages

(1) <u>UNSKILLED</u>	
Grade-I	Rs.130 per month plus a special allowance of Rs.10/-per month
Grade-II	Rs.130/- per month plus a special allowance of Rs.10/- to their sweepers who are engaged in loading rubbish in lorries.

#### (2) SEMI SKILLED:

Grade-I	Rs.150/- per month
Grade-II	Rs.140/- per month

#### (3) SKILLED:

Grade-I	Rs.170/- per month
Grade-II	Rs.160/- per month

In addition to the above wages, the employees (un-skilled, semiskilled) shall be eligible for Dearness Allowance as detailed below:-

**EXPLANATION**: 1. For calculating the daily rates of wages, the monthly rates of wages should be divided by the number of days in the month and vice-versa.

2. Wherever the nature of work is the same, no distinction shall be made in payment of wages to male and female employees.

#### NOTIFICATION-II

In exercise of the powers conferred by sub-section (2A) of section 26 of the Minimum Wages Act, 1948 (Central Act XI of 1948), the Governor of Tamil Nadu hereby direct that the provisions of sections 3 and 5 of the said Act shall not apply to such of those employees employed under any local authority who are in receipt of wages higher than the minimum rates of wages fixed under the said Act, subject to the condition that said employees continue to receive such higher rates of wages.
